

## Dog Waiver and Release of Liability

In consideration for being permitted to bring my dog to this event, I agree to the following terms and conditions:

1. Assumption of Risk: I understand and acknowledge that bringing my dog to the event involves inherent risks, including but not limited to the risk of injury to my dog, other dogs, and persons attending the event. I voluntarily assume all risks associated with participating in the event with my dog.
2. Release and Waiver: I hereby release, waive, discharge, and covenant not to sue Wags Bakery, at the event venue notated in this document, their respective affiliates, employees, agents, representatives, and volunteers (collectively referred to as "Released Parties") from any and all liabilities, claims, demands, actions, or causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by my dog or any other dogs, persons, or property as a result of my participation in the event, regardless of whether such loss, damage, or injury is caused by the negligence of the Released Parties or otherwise.
3. Indemnification: I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all liabilities, claims, demands, actions, or causes of action, including reasonable attorney's fees and costs, arising out of or related to my participation in the event with my dog, including but not limited to any claims by third parties alleging injury or damage caused by my dog.
4. Responsibility for Dog: I agree to be solely responsible for the actions and behavior of my dog at all times during the event. I understand that I must keep my dog under control and on a leash at all times, and I agree to promptly clean up after my dog and dispose of any waste in designated areas.
5. Compliance with Rules: I agree to comply with all rules, regulations, and instructions provided by the event hostess, event staff, or venue staff regarding the participation of dogs in the event.
6. Emergency Medical Treatment: In the event of any injury or medical emergency involving my dog, I authorize the event hostess, event staff, or venue staff to obtain emergency medical treatment for my dog as deemed necessary, and I agree to be financially responsible for any costs associated with such treatment.

I have read this Waiver and Release of Liability carefully and fully understand its contents. I am aware that by signing this document, I am giving up certain legal rights, including the right to sue the Released Parties. I voluntarily agree to the terms and conditions stated herein.
